

## PAY YOUR HOLIDAY GIVEAWAY- OFFICIAL RULES

**1. NO PURCHASE NECESSARY.** A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

**2. PROMOTION OVERVIEW:** The Pay Your Holiday Giveaway (the "Promotion") is sponsored by Gold Rush Amusements, Inc. ("Gold Rush Gaming"). The Promotion will be available to all Gold Rush Gaming affiliated licensed Establishments ("Establishment"). Each participating Establishment will have Entry cards available for distribution on a first come, first served/requested basis to those who meet the eligibility requirements set forth in Rule 3 below. Entry cards will be available to be distributed across all participating Establishments. Limit one entry per person per day, while supplies last. On Friday, January 31, 2020 at approximately 7:00 p.m. a designated team member or manager from the participating Establishment will select at random from all eligible entries one (1) Individual Establishment Finalist. The Individual Establishment Finalist will win \$100 in cash and will be entered into the Grand Prize Drawing that will be held on Friday, February 7, 2020 at approximately 1:00 p.m. Entry cards will be available while supplies last.

**3. ELIGIBILITY:** The Promotion is open to guests who are twenty-one (21) years of age or older at the time of entry and who are located in Illinois at the time of the participation in the Promotion ("Eligible Entrants"). Participants may be required to show a valid identification card (either a driver's license, state ID or passport) with the participant's photograph, name, address and age. The following persons are ineligible to participate in the Promotion and/or to receive/win a gift/prize or drawing entry, even if they otherwise meet the definition of an Eligible Entrant: employees, officers, directors, agents, successors and assignees of Gold Rush Gaming, their subsidiaries and affiliated companies, their advertising agencies, the participating Establishments, and any entities or persons involved in any way with the creation, administration or fulfillment of the Promotion, and the immediate family members (defined as spouse, parent, child, sibling, or grandparent; whether biological, adoptive, step or in-law) and those living in the same household (defined as those persons whether related or not who live in the same residence as the Eligible Entrant at any time during the Promotion Period) of such employees, officers, directors, agents, successors and assignees. Additionally, use of multiple email addresses or the manipulation of an entrant's contact information for the purpose of obtaining more than one (1) entry per day, is prohibited and such persons will be disqualified and all of their Entries shall be deemed invalid and any prize won by such person shall be forfeited. Entries must not contain inappropriate material as determined by Sponsor, in its sole discretion, to be considered eligible. Sponsor reserves the right to verify all entries. Void elsewhere and wherever prohibited or restricted by law.

**4. PROMOTION DATES:** The Promotion will begin on Monday, January 6, 2020 at 12:01 a.m. CST (or when establishment opens) and ends on Friday, January 31<sup>st</sup>, 2020 at approximately 6:50 p.m. CST (10 minutes prior to the Individual Establishment Finalist drawing that will occur at approximately 7:00 p.m.). On Friday, February 7, 2020 at approximately 1:00 p.m. a designated team member or manager from Gold Rush Gaming will select at random, from all eligible Individual Establishment Finalist entries, ten (10) Grand Prize Finalist Winners. Sponsors reserve the right to shorten or extend the Promotional Period. All times for this Promotion are Central Time.

**5. HOW TO ENTER:** During the Promotion Period, beginning on Monday, January 6, 2020, Eligible Entrants at each participating Establishment who request and receive an entry card shall be deemed "Participating Eligible Entrants". Limit one (1) entry card per day (while supplies last) per Eligible Entrant. No purchase of any kind, or gaming of any kind, is required for an Eligible Entrant to receive an entry card, but if an Eligible Entrant is not a seated guest, such Eligible Entrant must request an entry card from a guest service host or manager at the participating Establishment. Participants must be an Eligible Entrant to receive an entry card and must be a Participating Eligible Entrant to participate or receive/win a

prize. Each entry must be completed by the Participating Eligible Entrant with their full name and phone number and/or e-mail address and deposited into the entry box at the participating Establishment where the entry was awarded. No other form of entry is allowed. All entries will remain in the entry receptacles at the participating Establishments until the completion of the entry earning period on Friday, January 31<sup>st</sup>, 2020 at approximately 6:50 p.m. The following outlines the prize distribution.

**6. PRIZE WINNERS NOTIFICATION PROCEDURES:** On Friday, January 31, 2020 at approximately 7:00 p.m. a designated team member or manager from the participating Establishment will select at random from all eligible entries one (1) Individual Establishment Finalist. Individual Establishment Finalist Winners do not need to be present at the time of the drawing on January 31, 2020 to win. One unique Individual Establishment Finalist Winner will be chosen from each participating Establishment. If an Individual Establishment Finalist Winner's name (person) is drawn at a participating Establishment has also been drawn at another participating Establishment the second name / entry drawn be disqualified and another Finalist entry will be drawn. No person may have more than one entry into the Grand Prize Final Drawing. Finalists will be notified of their selection via telephone and if available via e-mail at the e-mail address provided on the entry card (the "Winner Notification"). If a Finalist (i) has not responded to Sponsor's email or phone call within two (2) days; (ii) does not fulfill the eligibility requirements; (iii) does not adhere to these official rules; and/or (iv) does not provide the required identification to Sponsor, the winner will be disqualified and an alternative finalist may be selected by random drawing from among all remaining entries. On Friday, February 7, 2019 at approximately 1:00 p.m. a designated team member or manager from Gold Rush Gaming will select at random, from all eligible Individual Establishment Finalist entries, ten (10) Grand Prize Winners, beginning with the five 10<sup>th</sup> through 6<sup>th</sup> Place \$1000 winners in reverse order concluding with the 1<sup>st</sup> Place Grand Prize winner. Grand Prize winners will be announced on Facebook Live from the Gold Rush Gaming Facebook Page. Grand Prize Winners do not need to be present or viewing Facebook Live at the time of the drawing to win. Winners may also be notified of their selection via telephone and if available e-mail at the e-mail address provided on the entry card (the "Winner Notification"). If a Grand Prize Winner (i) has not responded to Sponsor's email or telephone call within fourteen (14) days; (ii) does not fulfill the eligibility requirements; (iii) does not adhere to these official rules; and/or (iv) does not provide the required identification to Sponsor, the winner will be disqualified and an alternative Grand Prize Winner may be selected by random drawing from all remaining entries.

**7.CONDITIONS:** All taxes on Prizes are the sole responsibility of the winners. Entry cards are not transferable. One entry card per Eligible Entrant, per day for the entire Promotion.
